#### Safeguarding

All schools in England have been asked to raise awareness about the rise in reporting of financially motivated sexual exploitation. This type of crime involves an adult offender (often from an organised crime group based overseas) threatening to release nude or semi-nude images and/or videos of a child or young person, unless they pay money, or meet another financial demand, such as purchasing a pre-paid gift card.

We have been sent information from the National Crime Agency to distribute to parents – please see attached letter which contains guidance about how to talk to your child about financially motivated sexual extortion, and how to support them if they become a victim.

# Avoiding education and exam disruption from measles

The number of measles cases in England has increased significantly since October 2023.

With exams starting shortly, please could parents protect themselves and students, by ensuring they have had 2 doses of the measles, mumps and rubella (MMR) vaccine. It's never too late to catch up. If you are unsure of their vaccination status, please check their Red Book or speak to their GP. Vaccination is the best way to ensure measles does not prevent students from completing their exams.

#### **Experiences of the Work Place Project**

Year 9 'Experiences of the workplace project' - plea to employers! We endeavour to give students some form of 'experiences of the workplace' and we are delighted to be working with Speakers for Schools this year on a Year 9 project called 'Your Sustainable Future' (leaflet attached).

The intention is for students to work through a project under the theme of Net Zero set by an employer over the course of a couple of mornings, to give them a taste of what it would be like to be working for them and then also for them to visit the employer's premises to give them that experience of the workplace.

We have recruited a number of employers already but ideally need more so that we can have small groups of 25 students approximately per employer. The timetable is;

- Tuesday 25th June 9:15 12:30pm morning on site in school, introductions and introduce the project to the group of 25
- Wednesday 26th June group to visit your premises, 10-2pm with a member of staff from King James's School
- Friday 28th June 9:15 12:35pm morning on site in school, career tasks and students present project back to you




#### **Book Fair**

# **Get Ready!**

Speakers for Schools are proud to partner with the York and North Yorkshire Careers Hub, led by the York and North Yorkshire Combined Authority, to offer a programme of exciting and innovative introductions to careers which contribute to a sustainable future. This fully funded pilot that offers experiences of the workplace, reduces the barriers between business and education, and will be offered to students in year 9, at nine selected schools in North Yorkshire (one of seven areas taking part in this national pilot), with over 20 local employers.

"Your Sustainable Future" aims to:

- Support young people to better prepare for future careers and employment choices
- Increase engagement and access to employers working within the • net zero sectors and green industries
- Help develop the skills and behaviours needed to grow successful thriving business and infrastructure

Mapping to Gatsby Benchmark 6 this project provides students with the opportunity to:

- Complete a "real life" task set and supported by an employer
- Present solutions to "real life" problems to employers and receive feedback
- Identify information, advice and guidance on future pathways and next steps

**Employers will provide:** 

- A "real life" problem for your students to tackle
- Employees who can provide insights into their careers and support with the project task
- Employees who can attend your school to provide an overview of the sector and feedback on presentations
- A day at their place of work for 25-30 of your students to tour the facilities and meet employees

# The Programme

Students will be provided a workbook that includes all the relevant independent and group activities that they will be working on over the duration of the programme, to develop their solution/project ideas. Each school may work with multiple employers, taking small groups of 30 to cover your full cohort of year 9 students.

The programme structure:

#### Day 1:

Employer visits the school and students learn about the company. The employer will share presentations and set the project for the students. Students will meet the assigned employer.

#### Day 2:

Students will have an On-Site Visit at the employer's place of work. Students will meet members of staff, have a tour of the site and learn more.

#### Day 3:

Employer visits the school again. Students will share their solution/project ideas with a panel of employees, who provide constructive and honest feedback to support young people's reflections. Students will be provided with information on pathways to support future choices.

The programme will be delivered across 3 days between May and mid-July, subject to the school and employer's availability. Sue Gray, the Education Relationship Manager for the programme, will coordinate the scheduling with each school.

### **Parents and carers template letter**

Dear parent/guardian,

All schools in the UK have recently been sent information from the National Crime Agency, raising awareness of the recent rise in reporting of financially motivated sexual extortion (a type of online blackmail often known in the media as 'sextortion'). Children and young people worldwide are being targeted.

This type of crime involves an adult offender (often from an organised crime group based overseas) threatening to release nude or semi-nude images and/or videos of a child or young person, unless they pay money, or meet another financial demand, such as purchasing a pre-paid gift card.

Victims of any age and gender can be targets, however a large proportion of cases have involved male victims aged 14-18.

A child or young person is <u>never</u> to blame if they have been a victim. Offenders will have tricked, groomed and/or manipulated them into sharing an image.

#### Talking to your child

It's important to have frequent, open and non-judgemental conversations with your child about relationships, sex and being online to build trust and support them if something goes wrong. Financially motivated sexual extortion should be included in those conversations. Here are some tips about how to approach this:

- **Chat regularly about their life online:** have ongoing conversations with them about their life and time online. Continue to take an interest as they grow, explore new apps and sites together and talk in a balanced way, considering the benefits and the potential harms.
- Talk about where to find information about relationships and sex: organisations like <u>CEOP Education</u>, <u>Childline</u> and <u>Brook</u> have ageappropriate advice topics such as sexual communication and image sharing. This will help your child to understand what unhealthy relationships look like, such as applying pressure and blackmail; and give them trusted sources of information to explore these topics.

- Review privacy settings: talk to your child about the importance of using privacy settings on their accounts to restrict who can contact them. Read CEOP Education's advice on <u>how to talk your child about their</u> <u>privacy settings</u>.
- Make sure they know where to go for support: let them know that they can come to you with any concerns and won't be judged. It's also important to make them aware of other trusted adults or sources of support, if they feel they can't talk to you, such as Childline.
- Make sure they know where to report: remind your child how you can help them to report an incident to the police or using the CEOP Safety Centre. Let them know that if a nude or semi-nude of them has been shared without their consent, they can take these 3 steps to try and get them removed:
  - 1. Use <u>Report Remove</u>, a tool from Childline and the Internet Watch Foundation. Your child can use this to remove images that have been shared or might be shared.
  - 2. Use <u>Take It Down</u>, a tool from the National Center for Missing and Exploited Children. Your child can use this to remove or stop the online sharing of images or videos.
  - 3. Report directly to the platform or app that the incident has occurred on. For advice on how to report to major social media platforms, visit <u>Internet Matters</u>.

#### What can I do if this has happened to my child?

If your child tells you that someone is trying to trick, threaten or blackmail them online:

- **Don't pay, do stop contact and block:** you may be tempted to pay, but there is no guarantee that this will stop the threats. As the offender's motive is to get money, once you have shown you can pay, they will likely ask for more and blackmail may continue. If you have paid, don't panic but don't pay anything more. Help your child to stop all communication with the offender and block them on any accounts that they have been contacted on.
- Avoid deleting anything: try not to delete anything that could be used as evidence such as messages, images and bank account details.

• **Report to the police or CEOP:** call 101 or 999 if there is an immediate risk of harm to your child. Or you can use the <u>CEOP Safety Centre</u> to report any online blackmail attempts.

If it has already happened and your child has shared an image and sent money to someone exploiting them:

• **Reassure them that they've done the right thing by telling you:** make sure they know they are not to blame for what has happened and they have done the right thing to ask for your help.

Children and young people's mental health may be negatively impacted by experiences of exploitation; you can <u>find advice on looking after your</u> <u>child's mental health from the NHS</u>.

- **Report to the police or CEOP:** call 101 or 999 if there is an immediate risk of harm to your child. Or you can use the <u>CEOP Safety Centre</u> to report an incident. If your child is 18 and over, call 101 or 999 if they are at risk of immediate harm.
- **Report any images or videos that have been shared:** help your child to remove images that are online or prevent images being shared online by following these three steps:
  - 1. Use <u>Report Remove</u>, a tool from Childline and the Internet Watch Foundation. Your child can use this to remove images that have been shared or might be shared.
  - 2. Use <u>Take It Down</u>, a tool from the National Center for Missing and Exploited Children. Your child can use this to remove or stop the online sharing of images or videos.
  - 3. Report directly to the platform or app that the incident has occurred on. For advice on how to report to major social media platforms, visit <u>Internet Matters</u>.



#### HOW DO I JOIN?

Our 2024 Police Cadet recruitment is now open and you can apply on the North Yorkshire Police vacancies webpage or by scanning the QR Code on the back page of this leaflet. Recruitment closes 9am on Monday 13<sup>th</sup> May 2024. We are recruiting Police Cadets for our Harrogate, Malton and Scarborough units.

There are two online familiarisation events happening 6-7pm on 1<sup>st</sup> and 8<sup>th</sup> May, you can sign up to these events on the application page by scanning the QR code. Come online to learn more about Police Cadets and ask any questions you might have!

The application is an expression of interest and will ask for your details and why you want to join Police Cadets.

The next stage will be a short interview which will last approximately 20 minutes where we want to know more about you. The interview may take the form of an online Microsoft Teams call or as a face-to-face interview.

You will officially begin as a new recruit in September where you will start your learning and receive your own police cadet uniform. After the initial training you will pass out as a North Yorkshire Police cadet where your friends and family can watch you be awarded a certificate, after this you can join your unit on exciting events!
